Pavilion reservations do NOT	nclude use of pool, pool restrooms	or playground.

The playground may NOT be	eserved as part of a function. All ap	plicable park rules apply.	
All BBQ Pits/Grills must be se	lf-contained and placed (15) fifteen	feet from the Pavilion when in	use and NOT left unattended
